NOTE: Event admission is free to all guests. Each vendor will be provided with four (4) chili sampling trays for your staff/guests. Booth inspections will be conducted on the morning of the event, beginning at 7:30am. No food preparation may occur until your booth has been inspected. If your booth does not pass inspection, you will be asked to forfeit your space and registration fee. Your booth space does not come with any amenities or electrical power. Vehicular access is only available for loading/unloading. Parking will be provided nearby.

Please complete the following steps **no later than Friday, April 26, 2019**, to reserve your booth:

1. **Complete** this application and keep a copy for yourself;
2. **Write** a check to “Campbell San Jose West Rotary Foundation” for \$250 (please include “Chili Booth” on the memo line);
3. **Provide** a copy of a current Temporary Food Facility (TFF) OR Mobile Food Facility (MFF) permit. Visit www.campbellrotary.org/chili for links to permit applications.
4. **Provide** a copy of your Certificate of Liability Insurance certifying a minimum liability limit of \$1,000,000 per occurrence and naming “Rotary Club of Campbell” and “Campbell San Jose West Rotary Foundation” as Additional Insured OR **Write** a check to “Rotary Club of Campbell” for \$60 to be added to our club’s liability policy. (You will need to sign a separate contract.); AND
5. **Mail** all documents and fees to Cindy Method, OC3 Vendors Chair, 1986 Sycamore Glen, San Jose, CA 95125. You can also email documents to rotary@campbellrotary.org and pay fees online with a credit card at www.campbellrotary.org/donation.

IMPORTANT RULES: No firearms or outside alcohol are permitted onsite. All vehicles, coolers, bags, and hand carried items are subject to search upon entry. There will be live music at the event, and as such, no outside music may be played without prior approval of the Cookoff Chair. **This application must be signed and posted in your booth to acknowledge that you understand the rules and regulations of the event. Anyone found in violation of this contract will be asked to leave the event and be disqualified from all contests.**
